CHAIRPERSON ANDERSON: We will now continue our agenda. And we will now do our legal agenda.

The first matter on our legal agenda is a review of an Offer in Compromise in Lieu of Hearing dated August 20 -- August 31, 2020 for Case No. 20-CC-00001. It's Stop & Shop Liquors. And let me read the OIC.

The OIC is that the District of Columbia jointly with the licensed Respondent submits this Offer in Compromise, OIC, to the Alcoholic Beverage Control Board, as authorized by 23 DCMR, Section 1604.5, for approval by the Board. The parties understand that if the Board approves the OIC, this case will be -- will conclude and a scheduled show cause hearing will be vacated.

Respondent will be obligated to abide by the terms of the OIC, a fine, suspension, both, or other terms shown below. If the Board does not approve the OIC, the matter shall be continued to the scheduled show cause hearing currently set for October 7, 2020.

The Respondent has been advised that there is no obligation to accept an OIC.

Respondent has been advised that through service of the notice of status hearing and show cause hearing that a show cause hearing -- that at a show cause hearing, Respondent may be represented by legal counsel, have subpoenas issued to require the production of witnesses and evidence, produce witness and evidence, cross-examine witnesses, and apply to the Board for a qualified interpreter.

The terms of the OIC as follows. For charge one, restrictions in the use of signs.

The statutory authority is DC Code Section 25763D and 23 DCMR Section 1100.3. It's a fine of \$250, payable within 90 days, or the license will be suspended until the fine has been paid.

19	this is the license was cancelled in November
20	of 2019.
21	MEMBER GRANDIS: Yeah.
22	CHAIRPERSON ANDERSON: Ten days after
23	the Board makes a decision, the licensee has an
24	opportunity to contest the decision. This was
25	from November of 2019. The Licensee did not

contest this matter until August of 2020.

Between November of 2020 -- I'm sorry, between of November of -- between November of 1990 and August of 2020, it's more than ten days to request to contest the Board's decision.

So therefore, the decision that the recommendation today by the Board, it is because they have exceeded the ten-day threshold to contest our matter that the Board cannot grant it. It's on a technical --

MEMBER GRANDIS: Okay.

CHAIRPERSON ANDERSON: It's a technical violation based on our, the statute.

MEMBER GRANDIS: Okay, so I have two questions. I thought that the Board in certain situations, and maybe not in this statutory tenday situation, has ability to waive, to allow a hearing or something. So am I to understand that this ten-day is statutory, which I believe it is, and the Board does not have any leeway with that?

CHAIRPERSON ANDERSON: If the -- if you give us good cause. I mean, the bottom line is that you have ten days. It's like a court proceeding. You have -- you can appeal a matter in 30 days. You have ten days to appeal the

If you don't -- if you do not respond 1 matter. 2 within the ten days, then if you stated, if you 3 gave us a reason to say you never got a copy of 4 the notice, you weren't aware. But that was not the reason that was 5 If you read the -- if you read the 6 7 information, the person basically stated that the 8 reason why the license was not, they had a death 9 in the family, and that because of the 10 coronavirus, that's why they did not respond. 11 Well, the coronavirus --12 MEMBER GRANDIS: I understand, yes. 13 CHAIRPERSON ANDERSON: If the 14 coronavirus might have existed in November of 15 2019, in the United States. However, we were not 16 aware of it. So therefore you cannot --17 MEMBER GRANDIS: Yes, okay. 18 CHAIRPERSON ANDERSON: Use it as an 19 excuse in 2000, so that it was because of the coronavirus in October -- in November 2019 why 20 21 you did not respond within the time period. 22 MEMBER GRANDIS: And the death in the 23 family? 24 CHAIRPERSON ANDERSON: I am sorry, 25 sir, I do not know. Yes, I -- the individual had sent a letter in. I do not have the letter in front of me, but from what I can remember from reading the letter earlier, the two reasons were that there was a death in the family, and it was because of the coronavirus.

MEMBER GRANDIS: Okay.

CHAIRPERSON ANDERSON: And the request came to the Board in August of 2020, while the Board canceled the license in November of 2019.

MEMBER GRANDIS: And when we take this action today, is this, not licensee, is this individual or entity able to go to the Mayor's agent or to court, or is this done?

CHAIRPERSON ANDERSON: I, as far as I know, it is done. They have to reapply -MEMBER GRANDIS: Reapply.

CHAIRPERSON ANDERSON: For a new license. Because this was cancelled. They had an opportunity to contest it, and it was not done timely. And the reason that was given, it is because of the coronavirus and a death in the family. And as stated, we were not publically aware of the coronavirus in November of 2019.
