5 hearing status, the licensee is not required. So

7 hearing on October 23 at 10:30 a.m.

8 I just want to remind you, Ms.
9 Hogenmiller, that, if this matter goes to a show
10 cause hearing, seven day before the hearing the
11 parties are required to disclose documents and
12 witnesses to each side and to the Agency of the
13 documents that -- the documents and witnesses
14 that they will rely upon at the hearing. Failure
15 by either side to disclose the documents and
16 witnesses, unless reasonable cause is shown, the
17 Board will -- is empowered to prevent that side
18 from moving forward. Any questions, ma'am?

19 MS. HOGENMILLER: No.
