3 CHAIRPERSON ANDERSON: And with that,
4 we're at the end of our morning agenda. And so
5 since we're now at the end of our morning agenda,
6 I will now do our calendar items - agenda items,
7 I'm sorry.

8 So the first - I'm sorry - so the
9 first agenda that we will do this morning is our
10 "Legal Agenda." The first matter on our "Legal
11 Agenda" is the "Review of an Offer in Compromise
12 in Lieu of Hearing, dated September 18th, 2023,
13 the Case No. 23-CMP-00018, Ace Beverages, License
14 No. 014553." And the offer-in-compromise for
15 Ace Beverages, Charge 1 failed to obtain off-
16 premises storage permit, statutory authority 23
17 DCMR, Section 210.1. There's a warning for
18 Charge 2, transferred ownership without approval,
19 statutory authority D.C. Code Section 25-405.
20 There is a fine of \$1,000 paid within 30 days or
21 the license shall be suspended indefinitely until
22 the fine has been paid.

22 25705. There's a fine of \$250 paid within 30
23 days or the license will be suspended
24 indefinitely until the fine has been paid.

4 2020-147 by not revisiting security plan or using
5 uniforms for your security personnel, statutory
6 authority, D.C. Code Section 25-2386. There is a
7 \$1,000 fine paid within 30 days or their license
8 shall be suspended indefinitely until the fine is
9 paid.
