3 CHAIRPERSON ANDERSON: The next case  
4 on our calendar is Case Number 23-CC-00012,  
5 Sammy's Liquors, License Number 108222. Mr.  
6 Orellana, can you please elevate the rights of  
7 the parties in this case?

8 MR. ORELLANA: Maksym Shyyan, your  
9 access has been elevated. And Bisola Oni, your  
10 access has been elevated. That appears to be  
11 all, Chairman.

12 CHAIRPERSON ANDERSON: All right,  
13 thank you. Can we have the licensee, if you have  
14 a camera, can you turn the camera on please? All  
15 right. Okay. Good morning.

16 Ms. Bisola Oni, can you spell and  
17 state your name for the record please?

18 MS. ONI: Bisola Oni, B-I-S-O-L-A, O-  
19 N-I, on behalf of the Government. Government.

20 CHAIRPERSON ANDERSON: Good morning,  
21 ma'am. Mr. Shyyan, can you please spell and  
22 state your name for the record, and who you  
23 represent, sir?

24 MR. SHYYAN: Yes. Maksym Shyyan. I  
25 am the, one of the business owners of Sammy's

1       Liquors.   Liquor Store.

2                   CHAIRPERSON ANDERSON:   And spell your  
3       name for the record please, sir.

4                   MR. SHYYAN:   First name Maksym, M-A-K-  
5       S-Y-M, last name Shyyan, S-H-Y-Y-A-N.

6                   CHAIRPERSON ANDERSON:   Good morning,  
7       sir.  Ms. Oni, are there any preliminary matters  
8       in this case?

9                   MS. ONI:   Not at this time.

10                  CHAIRPERSON ANDERSON:   Any preliminary  
11       matters on your part, Mr. Shyyan?

12                  MR. SHYYAN:   Um --  
13                               (Simultaneously speaking.)

14                  CHAIRPERSON ANDERSON:   -- just any  
15       problems you are having since that day?

16                  MR. SHYYAN:   Problems, no.  I think  
17       there is an ongoing conversation with Alycia  
18       Hogenmiller.  We did receive an OIC, Offer-in-  
19       Compromise, a couple weeks ago which we have  
20       responded to a few days ago.  And I spoke with  
21       Alycia over the phone yesterday.  I guess she  
22       just didn't have probably enough time it sounded  
23       like to respond, to review our counteroffer.

24                               And as I understood from yesterday's  
25       conversation we might be receiving a

1 counteroffer, or their explanation on the  
2 position on --

3 CHAIRPERSON ANDERSON: Okay.

4 MR. SHYYAN: -- our counteroffer. So  
5 I guess I'm, that's what I wanted to find out, if  
6 I'm still waiting for a counteroffer or if we're  
7 proceeding to a status hearing on show cause.

8 CHAIRPERSON ANDERSON: Well, this  
9 matter is scheduled for a show case hearing on  
10 October 18th. The parties are welcome to have  
11 conversations prior to this time to see if this  
12 matter can be settled. And if this matter cannot  
13 be settled then we'll have a protest -- a show  
14 case hearing.

15 And just one thing I want to remind  
16 the parties, if this matter goes to a show cause  
17 hearing on October 18th, seven days prior to the  
18 hearing the parties are required to exchange  
19 documents and witnesses that they are going to  
20 rely on at the hearing. But as I stated, that  
21 Mr. Shyyan, if you believe that this matter can  
22 be settled, make sure you reach out to the  
23 assigned AAG for this case.

24 And, Ms. Oni, I would ask that the  
25 Assistant Attorney General should reach out to

1       mister, to the Applicant, or the Licensee,  
2       because it appears that the Licensee wants to  
3       have conversations.

4               MS. ONI: Yes. Those discussions are  
5       ongoing. Ms. Hogenmiller will reach out to you  
6       about that.

7               CHAIRPERSON ANDERSON: Okay.

8               MR. SHYYAN: Thank you. Excellent.

9               CHAIRPERSON ANDERSON: All right.  
10       Thank you for that representation, ma'am. As  
11       said before, if this matter is not settled then  
12       we'll see you on October 18th at 10:30 a.m., all  
13       right? Thank you very much. Have a great day.

14              MS. ONI: Thank you.

15              MR. SHYYAN: Thank you. Bye.

16              (Whereupon, the above-entitled matter  
17       went off the record at 11:00 a.m.)
