9 Compromise, dated September 20th, 2022, in Case  
10 Number 22-CMP-00028, Solace Outpost. License  
11 Number 117170.

12 And here are the terms of the Offer in  
13 Compromise.

14 Charge 1. Held conflicted interest in  
15 the manufacturing license in Virginia. Statutory  
16 Authority, D.C. Code Section 25303 and D.C. Code  
17 Section 25823A1.

18 There is a \$1,000 fine payable within  
19 120 days of the Board accepting an Offer in  
20 Compromise and if payment is not made within 120  
21 days, the license will be suspended until payment  
22 is made.

23 Charge Number 2. Failed to comply  
24 with the qualification for wholesalers or  
25 retailer's license. Statutory authority D.C.

1 Code Section 253021.

2 There's a fine of \$1,000 payable  
3 within 120 days of the board accepting an Offer  
4 in Compromise. If payment is not made within 120  
5 days, the license will be suspended until payment  
6 is received.

7 Charge Number 3. Failed to disclose  
8 ownership interest in the original ABRA  
9 application. Statutory authority, D.C. Code  
10 Section 25301A5 and 23 DCMR Section 501. This  
11 charge has been dismissed.

12 Charge 4. Transferred more than 50  
13 percent ownership without approval. Statutory  
14 authority D.C. Code Section 24401A.

15 There's a fine of \$1,000 payable  
16 within 120 days of the Board accepting the Offer  
17 in Compromise. And if payment is not made within  
18 120 days, the fine will be suspended until  
19 payment is received.

20 I, therefore, make a motion that the  
21 Board accepts this Offer in Compromise. Is there  
22 a second?

21 The Offer in Compromise is as follows.

22 Charge Number 1. Sale to a minor,  
23 secondary tier violation within two years.

24 There's a fine of \$3,000 to be paid within 60  
25 days or the ABC license will be suspended

1 indefinitely until the fine is paid.

2 The license shall be suspended for 10  
3 days with four days to be served consecutively  
4 within 60 days of the OIC date and 60 days stayed  
5 for one year.

6 The dates to be served are October  
7 14th through October 22nd.

8 Number 3. All employees who serve  
9 alcoholic beverages in the licensed establishment  
10 shall complete an alcohol training program within  
11 three months from the OIC date.

12 And Number 4. The licensee shall  
13 serve five days activated from Case Number 21-CC-  
14 00009. Those five days are November 10th through  
15 November 14th.

16 Charge 2. Failed to take reasonable  
17 steps necessary to ascertain legal drinking age.  
18 Second primary tier violation within two years.  
19 Statutory authority D.C. Code Section 25A2386.

20 There is a \$2,000 fine to be paid  
21 within 60 days or the ABC license will be  
22 suspended indefinitely until the fine has been  
23 paid.

24 I, therefore, make a motion that the  
25 Board accept this Offer in Compromise. Is there
