SCHLOM: Sure, first name is E-V-

1 A-N. Last name is Schlom, S-C-H-L-O-M. 2 MS. FLETCHER: Thank you very much. 3 So, Mr. Schlom, two of you are present from your 4 group today which means that, at the upcoming 5 status hearing, at least three more need to appear from the group that are not present today. 6 7 Today I'm granting conditional standing to the 8 group of eight. 9 We're not going to set a date for a 10 status hearing and a protest hearing today, 11 because we don't know the Board's availability 12 for those status and protest hearings at this 13 time. So we're just going to set a date for 14 mediation. 15 And I'm going to give you the next 16 available day. The next available day for 17 mediation is Thursday, October 29, at 9:00, 18 10:00, 11:00, 1:00 or 2:00. 19 MR. STOECKLEIN: I'm sorry, October 20 when? 21 It's Thursday, October MS. FLETCHER: 22 29th. 23 I'll defer to the others MR. SCHLOM: 24 in terms of their availability on that day. I 25 can do any time before 2 o'clock on the 29th.

MS. FLETCHER: I see that Pierson is 1 2 not available on that day. So let's see here. 3 What about, hold one second, how about Tuesday, October 27, Tuesday, October 27? 4 5 Is that good for you, Mr. Johnson? Is that good for you, Mr. Schlom? 6 7 MR. SCHLOM: I can only do in the 8 afternoon on that day. 9 MS. FLETCHER: Okay. What's a good time in the afternoon? 10 11 MR. SCHLOM: Two o'clock? 12 MR. JOHNSON: That will work here. 13 MS.
