13 now move to our supplementary licencing agenda.
14 There's one item on the Supplementary Licensing
15 Agenda, and that item is review application for a
16 stipulated license with letter of ANC support to
17 operate with new hours and entertainment
18 endorsement. This is for Laliguras, License No.
19 115606. I make a motion that we approve this
20 request. Is there a second?

21 MEMBER GRANDIS: Ed Grandis will
22 second.

23 CHAIRPERSON ANDERSON: Mr. Grandis has
24 second the motion. We'll now have a roll call
25 vote on the motion. Mr. Short?

1 MEMBER SHORT: Mr. Short, I agree.

2 CHAIRPERSON ANDERSON: Mr. Cato?

3 MEMBER CATO: Bobby Cato, I agree.

4 CHAIRPERSON ANDERSON: Ms. Crockett?

5 MEMBER CROCKETT: Rafi Crockett, I
6 agree.

7 CHAIRPERSON ANDERSON: Ms. Hansen?

8 The next request is from Foster C.
9 Gettys. It's a one day license, Class G. It's a
10 fundraising event for Common Good City Farm. The

12 The next request, another request from
13 Jesse B. Rauch, it's a one day license, Class G.
14 This is for MetroBar. The date of the event is
15 October 7th, October 8th, October 9th, and
16 October 10th, 2021. The license number is

18 Number 14 on the list, another request
19 from Jesse B. Rauch. This is a fundraising --
20 I'm sorry, hosing neighborhood event for
21 MetroBar. The date of the event is October 14th,

24 Number 15 on our list, another request

4 Number 16 is another request from
