3 CHAIRPERSON ANDERSON: Let us now go
4 to our Legal Agenda.

5 The first matter on our Legal Agenda
6 is the Review of an Offer in Compromise in Lieu
7 of Hearing, dated September 23, 2024 for Case No.
8 24-CIT-00091, Pho Viet, License No. 116771. The
9 offer and compromise for this case is as follows:
10 Charge 1, failed to file the required quarterly
11 statement secondary to your violation. Statutory
12 Authority, DC Code Section 25113(B) (2) (a).
