3 CHAIRPERSON ANDERSON: The next case  
4 on the calendar is Case No. 24-PRO-00090,  
5 Therapy, License No. 128751.

6 Mr. Orellana, can you please elevate  
7 the rights of the parties in this case?

8 MR. ORELLANA: Jovan Davis, your  
9 rights have been elevated.

10 And that appears to be all, Chairman.

11 MR. DAVIS: Okay. I'm here. I'm  
12 trying to find out how to (audio interference).

13 CHAIRPERSON ANDERSON: Is there anyone  
14 online for ANC 8C?

15 If there's anyone from ANC 8C -- who's  
16 sharing their -- okay, I can see --

17 MR. DAVIS: Okay. It's me.

18 CHAIRPERSON ANDERSON: All right, sir,  
19 yes. You can come back on camera, sir.

20 Is there anyone from ANC 8C?

21 Mr. Davis, what happened to you?

22 MR. DAVIS: I don't know. I don't  
23 know.

24 CHAIRPERSON ANDERSON: I saw you for  
25 a minute.

1 MR. DAVIS: Let's see.

2 CHAIRPERSON ANDERSON: I think you're  
3 doing it --

4 MR. ORELLANA: You're sharing the  
5 video. Click Start Video.

6 MR. DAVIS: I don't see that on my  
7 side.

8 CHAIRPERSON ANDERSON: All right. Is  
9 there anyone from ANC 8C on the call?

10 I can see you, Mr. Davis.

11 MR. DAVIS: Okay.

12 CHAIRPERSON ANDERSON: Is there anyone  
13 from ANC 8C on the call?

14 (No response.)

15 Calling once, calling twice. Anyone?  
16 If you're from ANC 8C, please identify yourself,  
17 so you can be elevated.

18 (No response.)

19 Mr. Davis, can you please spell and  
20 state your name for the record and your  
21 relationship to this case?

22 MR. DAVIS: My name is Jovan Davis,  
23 J-O-V-A-N Davis, D-A-V-I-S, owner of Love More  
24 Therapy.

25 CHAIRPERSON ANDERSON: Good morning,

1 sir.

2 This is a protest hearing and your  
3 application was protested by ANC 8C.

4 At the roll call, once when the  
5 placard notice went out, the roll call -- there  
6 was a roll call -- I'm sorry -- there was a roll  
7 call scheduled that both the protestor and the  
8 owner had to show up at the roll call. And it is  
9 just mandatory that the Licensee, the Applicant,  
10 and the protestants show up at this hearing, the  
11 protest hearing status.

12 This hearing was scheduled for 10:30  
13 this morning. It is now 11:04. I called the  
14 case and the Licensee is here, the Applicant is  
15 here, but there is no, as of 11:04, there is no  
16 representative from ANC 8C.

17 So, because there's no representative  
18 from ANC 8C, I am going to make a Motion to  
19 Dismiss their protest.

20 I, therefore, make a motion that the  
21 protest by ANC 8C be dismissed.

22 Is there a second?

23 MR. GRANT: Mr. Grant. I second the  
24 motion.

25 CHAIRPERSON ANDERSON: Mr. Grant has

1 seconded the motion.

2 We'll have a roll call vote.

3 Mr. Short?

4 MR. SHORT: Mr. Short. I agree.

5 CHAIRPERSON ANDERSON: Mr. Grant?

6 MR. GRANT: Mr. Grant. I agree.

7 CHAIRPERSON ANDERSON: And Mr.

8 Anderson. I agree.

9 And the matter passed 3-0.

10 What this means, Mr. Davis, the Board  
11 will address a motion, a Board order, dismissing  
12 ANC 8C's protest.

13 ANC 8C will have 10 days to provide  
14 reasonable notice, reasonable cause to this Board  
15 why they failed to show up today at the mandatory  
16 hearing.

17 If they fail to respond or if the  
18 Board determines that their reasoning for not  
19 showing up today is not reasonable, based on the  
20 action that the protest was dismissed, the Board  
21 will direct the agency to move forward to approve  
22 your license without any restrictions, sir.

23 Okay?

24 MR. DAVIS: Okay.

25 CHAIRPERSON ANDERSON: You have a

1 great day.

2 Thank you.

3 MR. DAVIS: All right. Thank you.

4 (Whereupon, at 11:06 a.m., the hearing  
5 was concluded.)
