3	CHAIRPERSON ANDERSON: Good afternoon
4	everyone, we're on the record.
5	Good afternoon everyone, my name is
6	Donovan Anderson, I'm Chairman of the ABC Board.
7	Joining us this afternoon are three
8	other members, four other members, I apologize.
9	Mr. James Short, Ms. Rafi Crockett, Ms. Jeni
10	Hansen, and Mr. Edward Brandis.
11	The Board has five members in
12	attendance this afternoon, and that constitutes a
13	quorum.
14	Before we get underway with this
15	afternoon's calendar, I need to make a few
16	instructions very clear so that the conduct of
17	these hearings is understood by everyone.
18	There are four cases scheduled for
19	this afternoon. Once your case is called, I will
20	take a moment for our IT specialist to elevate
21	the rights for each party, to enable their camera
22	and microphone.
23	Then and only then, will you have the
24	ability to enable your equipment.
25	If your case has not been heard, you

will remain mute and your camera will be 1 disabled. 2 3 At the conclusion of each case, the parties will have the option to leave. If the 4 5 party chooses to stay, all cameras and microphones for the concluded case will be 6 7 disabled. 8 Should you have any questions or 9 require technical assistance in the hearing, 10 please submit them using the chat feature. 11 All right, the first matter on our 12 afternoon calendar is the Board announcement 13 regarding the medical cannabis facility selection. 14 15 Today, the District of Columbia 16 Alcoholic Beverage Control Board, announces the results of the 2022 medical cannabis facility 17 18 application process. 19 By way of background for both the 20 process and the time line, the Board provides the 21 following. 22 On March 3, 2021, the Board announced 23 an open period by which persons and entities, 24 could submit letters of intent, to qualify for and obtain approval, to submit an application for 25

1	an available medical cannabis facility
2	registration in the District.
3	Available registrations included two
4	testing laboratories, one dispensary for either
5	Ward 3 or Ward 5, and two cultivation centers for
6	any Ward, excluding Ward 5.
7	The Board began accepting letters of
8	intent on March 22, 2021, and set a deadline for
9	May 21, 2021.
10	Only those persons and entities that
11	filed timely letters of intent, were eligible to
12	submit an application for a medical cannabis
13	cultivation center, dispensary, or testing lab.
14	Following the LOI phase of the
15	process, the Board started the application period
16	on November 29, 2021, and it set the application
17	deadline for March 28, 2022.
18	Based upon the limited number of
19	available registrations, it was not possible for
20	the Board to approve all timely submitted
21	applications.
22	After the application deadline passed,
23	applications were reviewed and scored by a multi
24	agency selection panel.
25	The selection panel was comprised of

ABRA, DCHealth, DCRA, DFS, DGS, DOEE, and OAG. 1 2 Upon the panels' completed review, 3 scores and comments were provided to the Board to evaluate each application. The Board has now 4 5 reviewed the scores and findings provided by the selection panel, and adopts them without 6 7 modification. Pursuant to 23 DCMR, section 5402.13, 8 9 the Board adopts the selection panel's reports 10 and findings, and announces the following 11 selection results. First, due to the failure of 12 any application for a testing laboratory to 13 achieve a high enough score, no testing lab 14 registrations are being issued at this time. 15 Second, the two selected cultivation 16 center applications are the ones filed by Renee and Andria Health, LLC, and Bouquet Labs DC, LLC. 17 18 Third, the selected dispensary 19 application is the one filed by Bouquet Labs DC, 20 LLC. 21 The Board also adopts the 22 recommendation of the selection panel for those 23 applications that were disapproved. 24 With respect to the applications filed 25 by Rooted Theraputics, Uxolo, LLC, and Amitie

Enterprises, the record will reflect that Board Member Crockett has removed herself from the selection process regarding those specific applications.

The Board further notes that all 5 applications will receive, applicants will 6 7 receive decision letters explaining the specific 8 reason for the application, that their 9 application was either approved or disapproved, as well as a copy of the final score rankings for 10 11 all applicants and the individual score sheets 12 related to their specific applications.

13 The Board emphasizes that today's 14 decision does not prevent, or otherwise 15 prejudice, unsuccessful applicants from seeking 16 to apply for a medical cannabis facility 17 registration with ABRA in the future.

For additional information, the Board directs applicants and members of the public to ABRA's website where additional documents and information related to today's decision and the selection process have been posted. Thank you. (Whereupon, the above-entitled matter went off the record at 1:43 p.m.)
