3 CHAIRPERSON ANDERSON: All right, we
4 now move to our show cause hearing status
5 calendar.

8 Moi Moi Restaurant, License No. 120466.

9 Mr. Orellana, can you please elevate
10 the rights of the licensee, and the government in
11 this case, please?

10 CHAIRPERSON ANDERSON: Oh, I'm sorry.
11 I was just reading. All right, I apologize. The
12 comments I was reading, the chat was that if
13 you're here, please advise.

14 All right, and so that this matter was
15 scheduled for a show cause hearing at status at
