The Alcoholic Beverage Control Board met via WebEx videoconference, Chairperson Donovan W. Anderson presiding.

CHAIRPERSON ANDERSON: All right, so we are at the end of our morning calendar and so what we are going to do now is, let me do our agenda starting off with our legal agenda.

The first matter on our legal agenda is a review offer in compromise involving the hearing dated September 9th, 2021. For Case Number 21-CC-00019, J\&D Market, License Number 103723.

The offer in compromise is as followed. Charge one, sold an alcoholic beverage to a person under 21 years of age. Statutory authority D.C. Code Section 2578(1), D.C. Code Section 25-82381.

The fine, a \$3,000 fine payable within 60 days of the Board accepting the OIC. And if the payment is not made within 60 days, the license will be suspended until payment is made.

Term two, a suspension. The license will be suspended for ten days, with four days to be served. The four days to be served are November 2nd, November 3rd, November 4th and November 5th. And the license, six days will be
stayed for one year providing no further infractions are found.

Term three, completion of alcohol awareness training for all employees who serve alcoholic beverages within three months from the date of the Board order approving the OIC.

Charge two, failure to take reasonable steps to ascertain legal and drinking age, statutory authority, D.C. Code 25783. This charge has been dismissed.
