the matter will be continued to the schedule show cause hearing, currently not set. The respondent has been advised that there is no obligation directed in the OIC.

5 Respondent has been advised through service of the notice of status hearing and show 6 7 cause hearing that at a show cause hearing, 8 respondent may be represented by legal counsel, 9 have subpoenas issued to require the productions 10 of witnesses and evidence, produce witnesses, 11 evidence, cross examine witnesses, and apply to 12 the Board for a qualified interpreter. The terms 13 are as follows.

14 Charge 1, failure to provide music at 15 an event in violation of 23 DCMR, I'm sorry, the 16 failure to provide food at an event in violation 17 of 23 DCMR Section 2000.1, set through authority 18 D.C. Code Section 823A1. This matter -- this 19 charge is dismissed.

20 Charge 2, no ABC manager or owner on 21 duty during an event in violation of 23 DCMR 22 Section 2000.2, set through authority D.C. 23 Official Code Section 823A1. The fine is a fine 24 of \$250, to be paid in 90 days, or the fine will 25 be suspended until payment is made.
