The Alcoholic Beverage Control Board met via WebEx videoconference, Chairperson Donovan W. Anderson presiding.

CHAIRPERSON ANDERSON: All right. So we now turn to the Board, that concludes the Board's calendar for the day, so the Board will now do our legal agenda. All right.

The first matter on our legal agenda is a review of an offer and compromise in lieu of a hearing dated September 14, 2020 for Case No. 18-CMP-000228, Flash, license number 105774. Mr. Grandis has -- will recuse himself for participation in this OIC.

The terms of the OIC is as follows. The District of Columbia, jointly with the licensee, submits this offer and compromise to the Alcoholic Beverage Control Board, as authorized by 23 DCMR Section 1604.5 for approval by the Board.

The parties understand that if the Board approves the OIC, this case will be -- will conclude, and any scheduled show cause hearing will be vacated. Respondent will be obligated to abide by the terms of the OIC, a fine, suspension, both, or other terms shown below.

If the Board doesn't approve the OIC,
the matter will be continued to the schedule show cause hearing, currently not set. The respondent has been advised that there is no obligation directed in the OIC.

Respondent has been advised through service of the notice of status hearing and show cause hearing that at a show cause hearing, respondent may be represented by legal counsel, have subpoenas issued to require the productions of witnesses and evidence, produce witnesses, evidence, cross examine witnesses, and apply to the Board for a qualified interpreter. The terms are as follows.

Charge 1, failure to provide music at an event in violation of 23 DCMR, I'm sorry, the failure to provide food at an event in violation of 23 DCMR Section 2000.1, set through authority D.C. Code Section 823A1. This matter -- this charge is dismissed.

Charge 2, no ABC manager or owner on duty during an event in violation of 23 DCMR Section 2000.2, set through authority D.C. Official Code Section 823A1. The fine is a fine of $\$ 250$, to be paid in 90 days, or the fine will be suspended until payment is made.
