5 Bluejacket/The Arsenal, Case No. 22-PRO-00096,  
6 Neighborhood Restaurant Group XIII, LLC, 300  
7 Tingey Street SE, License No. ABRA 090281.

8 This is a Retailer Class CR License  
9 Renewal. The protest issues are adverse impact  
10 on peace, order, and quiet, and vehicular and  
11 pedestrian safety.

12 My name is LaVerne Fletcher conducting  
13 the roll call hearing as the Board's agent. Is  
14 anyone present on behalf of the establishment?

15 MS. YOHANNES: Yes, Sidon Yohannes  
16 here on behalf of the licensee. That's S-I-D-O-N  
17 Y-O-H-A-N-N-E-S.

18 MS. FLETCHER: Thank you, Ms. Sidon.  
19 Is the applicant present as well?

20 MS. YOHANNES: No.

21 MS. BABIN: No, I'm present, Sidon.
