MS. FLETCHER: Good morning, everyone.

Thank you for participating in ABRA's roll call
hearing via the WebEx platform provided by the

D.C. Government, Office of Open Government.

My name is LaVerne Fletcher. I'll be conducting the roll call hearing as the Board's agent. There are three cases on the calendar today. The first case on the calendar is Birch and Barley/Churchkey, Case No. 22 PRO-00098, Neighborhood Restaurant Group VII, LLC, 1337 14th Street, NW, License No. ABRA 080839.

This is a Retailer Class CR License Renewal. The protest issues are adverse impact on peace, order, and quiet. My name is LaVerne Fletcher conducting the roll call hearing as the Board's agent. Is anyone present on behalf of the establishment?

MS. YOHANNES: Good morning. Sidon Yohannes here on behalf of the licensee. I believe the principal is here as well. That's Sidon Yohannes, S-I-D-O-N Y-O-H-A-N-N-E-S.

MS. FLETCHER: Good morning, Ms. Yohannes. Who did you say is here as well?

2	MS. FLETCHER: Okay. If you would
3	please state your name and spell it for the
4	record.
5	MS. YOHANNES: I think we have
6	MS. FLETCHER: Is that whose number
7	ends in 89?
8	MS. YOHANNES: I thought we had Ms.
9	Babin here, but we can move forward. That's
10	fine.
11	MS. FLETCHER: Okay. If he shows up
12	and if he shows up, he can introduce himself
13	at that time. Thanks, Ms. Yohannes.
14	Is anyone here on behalf of the Group
15	of VI?
16	MS. PITMAN: Hi. This is Sue Pitman,
17	the designated representative.
18	MS. FLETCHER: Thank you, Ms. Pitman.
19	Would you spell your name for the record, please?
20	MS. PITMAN: Yes. It's S-U-S-A-N P-
21	I-T-M-A-N.
22	MS. FLETCHER: Thank you, Ms. Pitman.
23	My understanding is that you are going to be
24	withdrawing the protest on behalf of the Group of
25	VI?

That's correct based on 1 MS. PITMAN: 2 a conversation with Ms. Babin. 3 MS. FLETCHER: Okay. And so what I'm 4 going to do, I'm going to go ahead and give you 5 dates for the upcoming status and protest hearing, but I'm not going to schedule mediation. 6 7 MS. PITMAN: Okay. 8 MS. FLETCHER: What I'm expecting 9 based on what you're saying, Ms. Pitman, is that 10 the status and protest hearing are also going to 11 be cancelled upon receipt of the withdrawal. 12 MS. PITMAN: That's correct. Can I 13 ask a question? 14 MS. FLETCHER: And so you will not 15 receive the status and protesting hearing invitations either because you will withdraw 16 17 before then. Just for the record, I'll tell you 18 what those dates are. 19 MS. PITMAN: Yes. 20 MS. FLETCHER: The status hearing is 21 set for November 2, 2022, at 10:30 a.m. 22 MS. PITMAN: Okay. 23 MS. FLETCHER: And the protest hearing 24 is set for December 14, 2022 at 1:30. I'm not 25 going to schedule mediation because I'm expecting

that you'll submit the withdrawal so we won't do 1 2 that. The Group of VI is granted conditional 3 standing today, Ms. Pitman, because you're here 4 today on behalf of the Group of VI. 5 MS. PITMAN: Yep. MS. FLETCHER: The group will be 6 7 granted full standing if at least four additional 8 people appear for the status hearing but it 9 doesn't appear that we are ever going to get to 10 that point. If we do, if the status hearing is 11 held, at least four people from the group that 12 aren't present today will need to appear at that 13 time. 14 MS. PITMAN: Okay. 15 MS. FLETCHER: Thank you very much. 16 Any questions about that? 17 MS. PITMAN: Yeah. I just want to know where there is an official withdrawal form? 18 19 MS. FLETCHER: No, not at all. As a 20 matter of fact, you know the email that you sent? 21 MS. PITMAN: Yes. 22 MS. FLETCHER: That would have been 23 fine if you had signed it. You can just send a 24 statement saying we withdraw the protest. If you

sign it, that will be sufficient.

15	MS. PITMAN: Okay. Oh, I didn't know.
16	Okay, thank you.
17	MS. FLETCHER: Just you as the
18	designated representative. That would be fine.
19	MS. PITMAN: Thank you.
20	MS. FLETCHER: You're welcome. That's
21	it, Ms. Pitman
22	Ms. Sidon, you know what happens next.
23	I'm sure you don't have any questions.
24	MS. YOHANNES: I have none.
25	MS. FLETCHER: Okay. Well, the roll
