3 CHAIRPERSON ANDERSON: The next case
4 in our calendar, we now move for a show cause
5 hearing status calendar, and the first case in
6 our show cause hearing status calendar is case
7 number 21-251-00040, Living Room, license number
8 769060. Mr. Orellana, can you please elevate the
9 rights of the government, and the licensee in
10 this case please?

11 MR. ORELLANA: Access has been
12 elevated. Kevin Lutes, your access has been
13 elevated. That is all chairman.

14 CHAIRPERSON ANDERSON: Thank you. All
15 right, good morning. Mr. Lutes, can you please
16 identify yourself for the record please?

17 MR. LUTES: Good morning Mr.
18 Chairperson, this is Assistant Attorney General
19 Kevin Lutes for the District.

20 CHAIRPERSON ANDERSON: Mr. Lutes, can
21 you please spell your name please for the record?

22 MR. LUTES: Of course. K-E-V-I-N L-U-
23 T-E-S.

24 CHAIRPERSON ANDERSON: Thank you, good
25 morning. Mr. Bailey, can you please spell, and

1 state your name for the record, and your
2 representation please?

3 MR. BAILEY: David Bailey, spelled D-
4 A-V-I-D, last name Bailey, B-A-I-L-E-Y.

5 CHAIRPERSON ANDERSON: And what is
6 your role in this matter this morning sir?

7 MR. BAILEY: I'm representing one of
8 the managers at Living Room night club,
9 unfortunately the owners cannot be here, they're
10 at another hearing pertaining to the club right
11 now, so I'm representing as authorized.

12 CHAIRPERSON ANDERSON: Thank you Mr.
13 Bailey. Mr. Lutes, are there any preliminary
14 matters in this case?

15 MR. LUTES: No preliminary matters Mr.
16 Chairperson.

17 CHAIRPERSON ANDERSON: All right,
18 thank you. Mr. Bailey, and Mr. Lutes, this
19 matter is scheduled for a show cause hearing on
20 October 26th, 2022 at 1:30 p.m. I just want to
21 advise both parties that seven days -- if this
22 matter goes to a hearing, seven days prior to the
23 hearing both parties must exchange documents, and
24 witnesses to be relied upon at the hearing.

25 If the parties fail to exchange

1 documents, and witnesses seven days before the
2 hearing, the board might prevent either side from
3 calling the witnesses, or relying on documents
4 that have not been disclosed unless reasonable
5 cause is shown. Has everyone understood?

6 MR. LUTES: Understood Mr.
7 Chairperson.

8 CHAIRPERSON ANDERSON: Mr. Bailey?

9 MR. BAILEY: Yes, that's understood.

10 CHAIRPERSON ANDERSON: All right,
11 thank you. All right, so if this matter's not
12 settled, see you then on October 26th, at 1:30
13 p.m. Thank you, have a good day.

14 MR. LUTES: Thank you.

15 MR. BAILEY: Thank you Mr. Chair.
