3 CHAIRPERSON ANDERSON: Good afternoon,
4 everyone. We are back on the record. All right,
5 before we call our first case this afternoon, I
6 want to continue -- this morning I did -- prior
7 to going on our lunch break this morning, I did
8 the Board's temporary one-day and license
9 substantial change docket. There were 19 cases
10 on that docket. There are 19 cases on the
11 docket; however, there was an additional case on
12 the docket that I need to add.

13 And number twenty on the Board's
14 temporary and one-day substantial change docket,
15 it's a request from Helen L. Qubain. This is for
16 a one-day license, Class F. This is for a
17 wedding on October 17th, 2021. The License No.
18 is 119689. And it is for 90 attendees.
19 Therefore I make a motion that the ABC Board
20 grants this event -- grants the license for this
21 event. Is there a second.

22 MEMBER CROCKETT: Ms. Crockett
23 seconds.

24 CHAIRPERSON ANDERSON: Ms. Crockett
25 has seconded the motion. I'll make a roll call -

1 - We'll now have roll call vote on the motion.
2 Mr. Short.

3 MEMBER SHORT: Mr. Short, I agree.

4 CHAIRPERSON ANDERSON: Mr. Cato.

5 MEMBER CATO: Bobby Cato, I agree.

6 CHAIRPERSON ANDERSON: Ms. Crockett.

7 MEMBER CROCKETT: Rafi Crockett, I
8 agree.

9 CHAIRPERSON ANDERSON: Ms. Hansen.

10 MEMBER HANSEN: Jeni Hansen, I agree.

11 CHAIRPERSON ANDERSON: Mr. Grandis.

12 MEMBER GRANDIS: Ed Grandis, I agree.

13 CHAIRPERSON ANDERSON: And Mr.

14 Anderson, I agree. The matter passed 6-0-0.

15 Good afternoon, everyone. Welcome to
16 the afternoon session of the ABC Board. And I
17 need to just make some clarifications or clear
18 the record for the public who are joining us for
19 the first time this afternoon. As you hear,
20 there are six board members. They all identified
21 themselves earlier. I'm Donovan Anderson. I'm
22 Chairman of the Board. The Board has six
23 members, so therefore we have a quorum this
24 afternoon.

25 Before we get underway with this

1 hearing calendar, I need to make a -- make a few
2 instructions very clear so that the conduct of
3 this hearing is understood by everyone. There
4 are two cases on our calendar, but there is
5 actually just one actual case. And if you're --
6 Once a case is called, I will ask for IT
7 specialist to elevate the rights of each party in
8 the case -- and the parties in the cases. I will
9 have the representative -- I will have the
10 Licensee and I will have the Protestants. They
11 will identify to me who the parties are.

12 If the representative for the Licensee
13 and the representative for the Protestants -- if
14 they do not inform me that anyone is not -- If
15 they do not identify specifically who the parties
16 are or who they intend to call in this case, your
17 rights will not be elevated. So therefore your
18 rights will not be elevated for you to
19 participate. You will just be a member of the
20 general public. So this is not the ABC Board
21 making this determination, it is a representative
22 of the Licensee and the representative of the
23 Protestants. They're the ones who are informing
24 us who are the parties in this case. And once
25 they have informed us, I will ask our IT

1 specialist to elevate that person's right.
