3 CHAIRPERSON ANDERSON: All right.

4 We're going to do now our legal agenda.

5 MS. JENKINS: Mr. Chairman?

6 CHAIRPERSON ANDERSON: I'm sorry,
7 who's speaking?

12 we got this OIC so late last night, you don't
13 have a Board order. But the paralegal is coming
14 in tomorrow to prepare it. And we're just going
15 to, it will look like every other Board order
16 you've done where we append the terms of the OIC.
17 And they will go out tomorrow. But it will have
18 your signature page. We're just not going to
19 send it to you, if that's okay with everyone.

20 CHAIRPERSON ANDERSON: Oh, that's
21 fine. Thank you --

22 MS. JENKINS: Thank you.

23 CHAIRPERSON ANDERSON: -- for bringing
24 that to our attention. Okay, thank you. All
25 right. Let's do, so we're doing our legal

1 agenda. The first matter on our legal agenda,
2 it's a review of an offer and compromise in lieu
3 of a hearing dated September 25th, 2020, Case
4 Number 19-CMP-00156. It is The Dirty Goose,
5 License Number 101299.

6 The terms of the OIC as follows,
7 Charge 1, increase summer garden occupancy,
8 statutory authority, DC Code, Section 25762(b)2.
9 And the Board will, there's only one charge, and
10 the Board will issue a written warning in this
11 matter. So therefore, I make a motion that we
12 accept the Board, I'm sorry, that we accept the
13 term of the OIC, offer of written warning. Is
14 there a second?
