18	B-S. That's for the court reporter.
19	Okay, I see you. Okay, anyone else
20	from the protestants?
21	(No response.)
22	MS. FLETCHER: Thank you. Is anyone
23	present on behalf of Cheers Wine and Spirits?
24	(No response.)
25	MS. FLETCHER: There is no one

present on behalf of Cheers Wine and Spirits. 1 2 The time is approximately 10:20. 3 application for the new license is dismissed 4 because the Applicant is not present. 5 ANC-5B does have standing as a protestant.
