3 MS. FLETCHER: The next case on the
4 calendar is Marte Bar and Lounge, Case Number 24-
5 PRO-00106, MGBK, LLC, 4815 Georgia Avenue NW,
6 License Number ABRA-125774. This is a Retailer
7 Class CT Tavern for a substantial change for the
8 change of hours of operation and alcoholic
9 beverage sale, service, and consumption. My name
10 is LaVerne Fletcher conducting the roll call
11 hearing as the Board's agent. The protest issues
12 in this matter are adverse impact on peace,
13 order, and quiet. Is anyone present on behalf of
14 Marte Bar & Lounge?

15 MS. KERR: Roxan Kerr on behalf of
16 Marte Bar & Lounge. Good morning, Ms. Fletcher.

17 MS. FLETCHER: Good morning. Could you
18 please state your name one more time and spell it
19 for the record?

20 MS. KERR: Roxan Kerr, that is R-O-X-A-
21 N, last name is K-E-R-R.

22 MS. FLETCHER: What is the first name
23 again?

24 MS. KERR: Roxan, R-O-X-A-N.

25 MS. FLETCHER: Oh, R-O-X-A-N, okay.

1 There is no E on the end of Roxan?

2 MS. KERR: No, ma'am.

3 MS. FLETCHER: Thank you. Ms. Kerr,
4 for the email address that we have for you this
5 is not the first name. Should we change your
6 name in the record? What I have here is
7 someone's first name is M-I-S-R-A-K, same last
8 name. Is that you?

9 MS. KERR: No, it is not. That is the
10 owner.

11 MS. FLETCHER: So should we use the
12 same email address to reach you?

13 MS. KERR: No, ma'am. I did not enter
14 my appearance yet because I did not know I would
15 be here today. So I will enter my appearance and
16 you will have my information.

17 MS. FLETCHER: So, Ms. Kerr, are you
18 the attorney representing the lounge?

19 MS. KERR: I am.

20 MS. FLETCHER: Okay, so once you enter
21 your appearance then we will update the record.

22 MS. KERR: Excellent.

23 MS. FLETCHER: Ms. Kerr, do you have my
24 email address?

25 MS. KERR: I do.

1 MS. FLETCHER: Okay. Thank you, thank
2 you very much. Is anyone present on behalf of
3 ANC 4D?

4 Is anyone present on behalf of ANC 4D?

5 The time is approximately 10:40 a.m.
6 There is no one present on behalf of ANC 4D. ANC
7 4D is dismissed as a protestant. Ms. Kerr, a
8 Board order will be issued to that effect, and
9 you will receive a copy of the Board order. If
10 ANC 4D decides to seek reinstatement of their
11 protest you will receive a copy of that as well
12 and have an opportunity to respond, and the Board
13 will determine whether or not to reinstate the
14 protest filed by ANC 4D, but they are --

15 MS. KERR: Excellent. In the meantime
16 -- go ahead.

17 MS. FLETCHER: -- they are dismissed
18 today because they are not present.

19 MS. KERR: Correct, and so at this
20 point after the Board submits their order
21 regarding that at what point will my client
22 request be granted.

23 MS. FLETCHER: Request what, Ms. Kerr?

24 MS. KERR: They requested a change in
25 hours, and so if there is no protest then how

1 quickly will they be given the opportunity to get
2 their hours changed?

3 MS. FLETCHER: It depends what happens
4 next. First the Board order is issued dismissing
5 the protest because the ANC 4D is not here.

6 MS. KERR: Okay, no problem. Thank
7 you, Ms. Fletcher.

8 MS. FLETCHER: They will have ten days
9 to seek reinstatement.

10 MS. KERR: Got you.

11 MS. FLETCHER: Then you will have seven
12 days to respond to that. So it all depends on
13 whether or not the Board reinstates the protest.

14 MS. KERR: I understand. Thank you,
15 Ms. Fletcher. Have a great day.

16 MS. FLETCHER: You are very welcome.
17 Thank you. The show cause hearing --

18 MS. KERR: Okay. Bye, bye.

19 MS. FLETCHER: You too, bye, bye. The
20 roll call hearing in the matter of Marte Bar &
21 Lounge is concluded.
