Charge 3, failed to post license, statutory authority, D.C. Code Section 71-181.

Cancellation, within seven days of the Board's approval of this offer in compromise, the licensee shall surrender the license to ABRA for cancellation. Charge 4, operated outside of sidewalk caf, approved hours, statutory authority, D.C. Code Section 25-726(b)(13).

The fine and -- or what has been agreed to is cancellation within seven days of the Board's approval of this offer in comprise. The license shall be surrendered -- shall surrender the license to ABRA for investigation. Charge 5, fail to post warning sign, statutory authority, 23 DCMR Section 719.

The fine is at -- in this particular case, it's the cancellation of a license. Within seven days of the Board's approval of this offer in compromise, the licensee shall surrender the license to ABRA for cancellation.
