4 on our calendar is Case Number 22-CMP-00047,
5 Boulevard Lounge, License Number 115385. Mr.
6 Orellana, can you please elevate the rights of
7 the licensee in this case, please?

8 MR. ORELLANA: (Audio interference) in
9 attendance.

10 CHAIRPERSON ANDERSON: Fine. I want
11 to make sure, I'm looking at my -- to make sure
12 it's Mr. O'Brien's case.

13 MR. O'BRIEN: I'm sorry, Mr. Chair,
14 would you call the case again, please?

15 CHAIRPERSON ANDERSON: This is
16 Boulevard Lounge, 22-CMP-00047. Is this -- is
17 that your case, Mr. O'Brien?

18 MR. O'BRIEN: No, sir.

21 CHAIRPERSON ANDERSON: All right.

21 matter goes to a hearing, seven days prior to the
22 hearing, each party -- the parties are required
23 to exchange documents and witnesses. Failure by
24 either side to provide us with documents and
25 witnesses, the Board is empowered to prevent that

1 side from moving forward to rely on documents and
2 witnesses unless good cause is showing for its
3 failure to disclose these documents. Okay. All
4 right. Thank you very much, Mr. Lutes, for being
5 here this morning, and I believe that our
6 business has concluded with you. So have a great
7 day, sir.

8 MR. LUTES: Of course. Thank you so
9 much, Mr. Chairperson. Have a great rest of your
10 day.

12 much. Take care.
