5 After Twelve, License No. 117238.

6 Mr. Orellana, good morning again. Can
7 you please elevate the rights of the attorney for
8 the government and the licensee, please?

9 MR. ORELLANA: Access has been
10 elevated. Evan Lutes, your access has been
11 elevated.

5 MR. LUTES: As a preliminary matter
6 the District has communicated an OIC to the
7 licensee and at this point the District and
8 licensee are still in talks.

9 CHAIRPERSON ANDERSON: Thank you.

10 All right, this matter then is
11 scheduled for a show cause hearing on November
12 9th, 2022 at 10:30 a.m. I would like to remind
13 the parties that seven days before the hearing,
14 if this matter is not settled seven days before
15 the hearing, the parties are required to exchange
16 documents and witnesses with the other side and
17 also provide a copy of those documents and
18 witnesses to the government; failure by either
19 side to provide documents and witnesses seven
20 days prior to the hearing, the Board may prevent
21 that side from moving forward with documents and
22 witnesses if they have not been introduced,
23 unless good cause has been shown.

25 MS. YOHANNES: No questions by the

1 licensee.

2 MR. LUTES: No questions for the
3 District, Mr. Chairperson.
