4 next case on our calendar is Case No.
5 21-CC-00022, Open Door Market, License No.
6 109402.

7 Ms. Andrews, can you please elevate
8 the parties for this case, please?

9 MS. ANDREWS: Mr. Chair, there are no
10 parties for this case.

11 CHAIRPERSON ANDERSON: Well, Ms.
12 Jordan is on the line. She's the attorney of
13 record.

14 So, you're saying that there is no
15 licensee on the --

16 MS. ANDREWS: Correct, the licensee
17 has not appeared.

18 CHAIRPERSON ANDERSON: All right. All
19 right. All right. All right.

20 So, Ms. Jordan, spell and state your
21 name for the record, please.

22 MS. JORDAN: Good morning.

23 Janika Jordan, on behalf of the
24 Government. J-A-N-I-K-A J-O-R-D-A-N.

25 CHAIRPERSON ANDERSON: All right.

1 It's my understanding that, although the licensee
2 has been served, the licensee has failed to
3 appear this morning.

4 This matter, then, is scheduled for a
5 show case hearing on November 3rd, 2021, at 10:30
6 a.m.

7 And, Ms. Jordan, is this your case or
8 does it belong to another attorney at the office?

9 MS. JORDAN: This case belongs to
10 Antoine Williams.

11 CHAIRPERSON ANDERSON: Can you please
12 ensure that Mr. Williams contacts the licensee?
13 I know that the licensee has been served to be
14 provided -- the licensee was served and was
15 provided the date of today's show cause hearing
16 status. I'm also aware that the licensee was
17 served, and they were also provided the date of
18 the show cause hearing on November 3rd, 2021, at
19 10:30 a.m. But, as a courtesy --

20 MS. ANDREWS: Mr. Chair --

21 CHAIRPERSON ANDERSON: I'm sorry.
22 Yes? Yes, Ms. Andrews?

23 MS. ANDREWS: We do have Sidon
24 Yohannes on the line, representing the licensee.

25 CHAIRPERSON ANDERSON: For Open Door

1 Market?

2 MS. ANDREWS: Yes. She just sent a
3 message in the chat. So, I'm going to elevate
4 her rights.

5 CHAIRPERSON ANDERSON: Sure.

6 Ms. Yohannes?

7 MS. YOHANNES: Yes. Good morning.

8 CHAIRPERSON ANDERSON: Good morning.

9 Can you spell and state your name for
10 the record, please? And who you represent?

11 MS. YOHANNES: Sidon Yohannes,
12 S-I-D-O-N Y-O-H-A-N-N-E-S. And I represent the
13 licensee, Open Door Market. And we will go ahead
14 and enter our appearance as necessary in this
15 case.

16 CHAIRPERSON ANDERSON: Thank you very
17 much. I was just about to ask that.

18 All right. So, I guess the assumption
19 is that there's been no conversation between
20 yourself and the Government. Is that correct?

21 So, I will ask, are there any
22 preliminary matters?

23 All right. Ms. Jordan, again, who's
24 case -- who is representing the Government in
25 this case again, please, Ms. Jordan.

1 MS. JORDAN: Mr. Antoine Williams is
2 representing the Government.

3 CHAIRPERSON ANDERSON: Okay. Thank
4 you, Ms. Jordan.

5 Now, Ms. Yohannes, you're aware that
6 Mr. Antoine Williams is the Government's
7 attorney.

8 This matter is scheduled for a show
9 cause hearing on November 3rd, 2021, at 10:30
10 a.m. The parties are instructed, if they so
11 desire, to talk. If this matter can be settled,
12 you can send terms to the Board; the Board might
13 look at it. If not, we will have a show cause
14 hearing on November 3rd, 2021, at 10:30 a.m.

15 I just want to remind both parties
16 that seven days before the hearing both parties
17 are directed to exchange documents and witnesses
18 with each side, and also with the Agency. So,
19 therefore, we will have documents and witnesses
20 set. If we go to a hearing, all the parties will
21 be onboard who the witnesses are and what
22 documents will be relied upon by both sides. All
23 right?

24 Thank you very much and have a great
25 day.

1 MS. YOHANNES: Thank you.

2 MS. JORDAN: Thank you, Mr.

3 Chairperson.

4 CHAIRPERSON ANDERSON: All right.
