7 Charge One, made substantial changes in operation  
8 of the licensed establishment without obtaining  
9 approval. Statutory authority DC Code Section  
10 82-3A3 and DC Code Section 25-762. The fine not  
11 applicable. Number Two, suspension not  
12 applicable. Term Three of this OIC, the licensee  
13 will surrender the license for safekeeping.  
14 Following the board's approval of this offer in  
15 compromise respondent shall immediately cease all  
16 sale and service of alcohol and ensure that all  
17 alcoholic beverages are secure and not accessible  
18 to the public for sale, service or consumption.  
19 Respondent shall surrender the license for  
20 safekeeping and all alcohol will be removed from  
21 respondent's premise by 12:00 p.m. 14 days after  
22 the board's approval of this OIC.

23 Respondent's owner, Dessalgen  
24 Niguissie, certifies by this agreement that he  
25 has no ownership interest in the new license

1 holder, Marki Woldemariam, who is a bona fide  
2 purchaser. Respondent may not withdraw the  
3 pending transfer application if the board  
4 disapproves the transfer, but may file a new  
5 transfer application within 30 days of this  
6 approval. If the license is not transferred to a  
7 new owner, who is a bona fide purchaser by April  
8 25, 2023, the license shall be deemed canceled by  
9 the board provided that any request for an  
10 extension for reasonable cause may be made to the  
11 board and granted or denied at its discretion.

12 Charge Two, operated under a trade  
13 name not approved by ABRA, statutory authority DC  
14 Code Section 25-823A1, 23 DC MR Section 600.  
15 Fine not applicable. Suspension not applicable  
16 and other term see Charge One above which was the  
17 other term in the sense that the license will be  
18 placed into safekeeping. I make a motion that
