Following the board's approval of this offer in compromise respondent shall immediately cease all sale and service of alcohol and ensure that all alcoholic beverages are secure and not accessible to the public for sale, service or consumption. Respondent shall surrender the license for safekeeping and all alcohol will be removed from respondent's premise by 12:00 p.m. 14 days after the board's approval of this OIC.

Respondent's owner, Dessalgen Niguissie, certifies by this agreement that he has no ownership interest in the new license
holder, Marki Woldemariam, who is a bona fide purchaser. Respondent may not withdraw the pending transfer application if the board disapproves the transfer, but may file a new transfer application within 30 days of this approval. If the license is not transferred to a new owner, who is a bona fide purchaser by April 25, 2023, the license shall be deemed canceled by the board provided that any request for an extension for reasonable cause may be made to the board and granted or denied at its discretion. Charge Two, operated under a trade name not approved by ABRA, statutory authority DC Code Section 25-823A1, 23 DC MR Section 600. Fine not applicable. Suspension not applicable and other term see Charge One above which was the other term in the sense that the license will be placed into safekeeping. CHAIRPERSON ANDERSON:\& Mr. Anderson, I agree. The matter passed 4-0-0. I just want to alert the public, as long as three members are on the board, that is a quorum. So, although there are only four members participating, I just want to let the public know that as long as there are three members, a minimum of three members, participating we have met our burden to have a quorum to operate.
