5 The offer in compromise is as follows.
6 Charge 1, sale of alcoholic beverage to a person
7 under 21 years of age, statutory authority DC
8 Code Section 25-781. There is a fine of \$2,000
9 to be paid within 60 days or the license will be
10 suspended until the fine has been paid.

11 Number 2 of Charge 1 is there is a
12 suspension. The license will be suspended for
13 five days with all five days stayed for one
14 year.

15 Term 3 of Charge 1 is that all
16 employees who serve alcohol shall complete an
17 alcohol awareness training within 90 days of the
18 Board accepting the offer in compromise.

19 Charge 2, failure to take reasonable
20 steps necessary to ascertain legal drinking age,
21 statutory authority DC Code Section 25-783.
22 There is a fine of \$1,000 to be paid within 60
23 days or the license will be suspended until the
24 fine has been paid.

25 I therefore make a motion that the

1 Board accepts this offer in compromise. Is there
2 a second?
