12 4th, 2020 for the purpose of seeking legal
13 advice from our counsel on the matters
14 identified on the Board's legal licensing and
15 investigative agenda for November 4th, 2020 as
16 published in D.C. Register on October 30th,
17 2020.

18 Is there a second?

19 MEMBER WAHABZADAH: Ms. Wahabzadah,
