20 is November 10th, the license number 130432, 100  
21 attendees, two security guards. Approval.

22 Number six, another request from Lana  
23 El-Zein, a one-day license Class F, concert, live  
24 music performance. This is November 22nd and  
25 November 23rd. The license number is 130433, 100

1 attendees, two security guards. Approval.

2 Number seven, another request from  
3 Lana El-Zein, a concert, live music performance.  
4 This is November 27th. The license number is  
5 130434, 100 attendees, two security guards.  
6 Approval.

7 Number eight, another request from  
8 Lana El-Zein, a one-day license, Class G,  
9 concert, live music performance. This is  
10 November 2nd. The license number is 130435, 100  
11 attendees, two security guards. Approval.

12 Number nine, another request from Lana  
13 El-Zein, one-day license, Class G, concert, live  
14 music performance. This is November 8th. The  
15 License number is 130436, 100 attendees, two  
16 security guards. Approval.

17 Number ten, another request from Lana  
18 El-Zein, one-day license Class G, concert, live  
19 music performance. This is November 16th. The  
20 license number is 130437, 100 attendees, two  
21 security guards. Approval.

22 Number 11, another request from Lana  
23 El-Zein, one-day license Class G, concert, live  
24 music performance. This is November 23rd. The  
25 license number is 130438, 100 attendees, two

1 security guards, approval.

2 Number 12, a request from Kaitlin  
3 Krell, one-day license, Class G, for a reception.  
4 This is November 1st. The license number is  
5 130428, 200 attendees, four security guards.  
6 Approval.

7 Number 13, a request from Patrick  
8 DiBattista, one-day license, Class G, western  
9 line dance class, November 16th, the license  
10 number 130477, 200 attendees, four security  
11 guards. Approval.

12 Number 14, another request from  
13 Patrick DiBattista, one-day license, Class G,  
14 western line dance. This is December 7th. The  
15 license number is 130478, 200 attendees, four  
16 security guards. Approval.

17 Number 15, Tony and Joe's Seafood  
18 Place, a one-day substantial change, New Year's  
19 Eve celebration. Nature of substantial change,  
20 use license off-premises in between common areas.  
21 This is December 31st. The license number is  
22 010762. The substantial change license is 24-SC-  
23 01085. This is recommendation conditional  
24 approval.

9 treatment facility endorsement application for a  
10 retail license. This is for Wash Hydro LLC,  
11 License Number 126952. Recommendation for  
12 placard.

13 Request number five, review of  
14 safekeeping extension request for an additional  
15 60 days for a cultivation center, Capital City  
16 Care, License Number 117368. Recommendation,  
17 approval.

18 Number six, review of safekeeping  
19 extension request for an additional 60 days for  
20 manufacture. This is for Capital City Care,  
21 License Number 125472. Recommendation, approval.

22 Number seven, review of safekeeping
