3 CHAIRPERSON ANDERSON: Good afternoon,
4 everyone, and welcome to the afternoon session of
5 the ABC Board. My name is Donovan Anderson. I'm
6 Chairman of the Board. I'm joined by two other
7 Members this afternoon, Mr. Bobby Cato and Mr. Ed
8 Grandis. I just want to assure the general
9 public that a quorum for the ABC Board is three
10 members. As long as there are three members
11 present, we do have a quorum, and we have a
12 quorum this afternoon to conduct business.

13 All right. So before we get underway
14 with this afternoon's hearing calendar, I need to
15 make a few instructions very clear so that the
16 conduct of these hearings is understood by
17 everyone. There are actually three cases
18 scheduled for our afternoon calendar. Once your
19 case is called, I will take a moment for our IT
20 Specialist to elevate the rights for each party
21 to enable their camera and microphone. Then and
22 only then will you have the ability to enable
23 your equipment. If your case is not being heard,
24 you will remain mute and your camera will be
25 disabled.

1 At the conclusion of each case, the
2 parties will have the option to leave. If the
3 party chooses to stay, all cameras and
4 microphones for the concluding cases will be
5 disabled.

6 Should you have any questions or
7 require technical assistance during the hearing,
8 please submit them using the question and answer
9 feature.

10 So our first case this afternoon --
11 I'm going to call the cases out of order -- so
12 the first case I'll call this afternoon -- better
13 yet, let me -- the first case I'm going to call
14 is Case Number 22-PRO-00052, Surfside. This case
15 has been cancelled due to the ANC's withdrawal of
16 the protest.
