4 next case in our calendar is Case No. 19-CC-  
5 00134. Towne Wine & Liquor.

6 Ms. Andrews, can you please elevate  
7 the owner of Towne Wine? I think I have the --  
8 Mr. Chae Joey Chen as the owner of Towne Wine &  
9 Liquor.

10 MS. ANDREWS: Mr. Joey Chen, you are  
11 now a panelist. And, Mr. Minora, you are now a  
12 panelist.

13 (Discussion off the record.)

14 MR. CHEN: Hello.

15 CHAIRPERSON ANDERSON: Good morning.  
16 Can the parties identify themselves  
17 for the record, starting with the Government,  
18 please.

19 MR. ORTIZ: Stephen Ortiz on behalf of  
20 the District of Columbia.

21 CHAIRPERSON ANDERSON: Good morning.  
22 And, Mr. Minora, can you identify  
23 yourself for the record and also spell your name,  
24 please.

25 MR. MINORA: Sure. Matthew Minora from

1 the law firm of Mallios & O'Brien, an ABC  
2 licensed counsel for the licensee. My last name  
3 is spelled M-I-N-O-R-A.

4 CHAIRPERSON ANDERSON: And is the  
5 licensee on the line also, Mr. Minora?

6 MR. MINORA: Correct, yes. Joey Chen.

7 CHAIRPERSON ANDERSON: Mr. Chen, can  
8 you identify yourself for the record and spell  
9 your name, please.

10 MR. CHEN: Yeah. Joey Chen, J-O-E-Y.  
11 Last name C-H-E-N.

12 CHAIRPERSON ANDERSON: And good  
13 morning, Mr. Chen. Good morning, Mr. Minora.  
14 Good morning, Mr. Ortiz.

15 And, Mr. Minora -- I'm sorry, Mr.  
16 Ortiz, are there any preliminary matters in this  
17 case?

18 MR. ORTIZ: There are no preliminary  
19 matters at this time.

20 CHAIRPERSON ANDERSON: Alright. Thank  
21 you. Since there are no preliminary matters in  
22 this case, the Board will set this matter for a  
23 show cause hearing at a date to be determined.

24 And, Mr. Minora, because of the  
25 pandemic, the Board normally would be aware -- we

1 would issue a date for the show cause hearing at  
2 this matter.

3 But because -- we're still working the  
4 process out. So, the Agency will inform both  
5 yourself and Mr. Ortiz of the date for a -- the  
6 show cause hearing.

7 If this matter can be settled, I would  
8 suggest that the parties continue to talk and let  
9 the Board know whether or not -- and then we can  
10 schedule a date much more quickly if we will have  
11 a preliminary matter. Okay?

12 So, if there are no other questions or  
13 concerns, this matter is adjourned.

14 MR. MINORA: Thank you.

15 CHAIRPERSON ANDERSON: Alright. Thank  
16 you very much.

17 MR. CHEN: Thank you.

19 hearing was adjourned.)
