3 MS. FLETCHER: The next case on the
4 calendar is 1942 DC.

5 This is Case Number 22-PRO-00103,
6 Etete Ethiopian Cuisine, Inc. 1942 9 Street
7 Northwest, License Number ABRA 070728. This is a
8 Retailer Class CT License Renewal.

9 The protest issues are adverse impact
10 on peace, order, and quiet, residential parking,
11 and vehicular and pedestrian safety, and density.

12 Is anyone present on behalf of 1942
13 DC?

14 MS. YOHANNES: Yes, good morning.
15 Sidon Yohannes here on behalf of the Licensee, S-
16 I-D-O-N, Y-O-H-A-N-N-E-S.

17 MS. FLETCHER: Thank you, Ms.
18 Yohannes.

19 Is anyone else present with you today,
20 Ms. Yohannes, from 1942?

21 MS. YOHANNES: No, I don't believe so.

22 MS. FLETCHER: Is anyone present on
23 behalf of ANC 1B?

24 (No audible response.)

25 MS. FLETCHER: We have to allow

1 parties 10 minutes to appear. The time is 10:07
2 so we'll wait for three more minutes.

3 (Whereupon, the above-entitled matter
4 went off the record at 10:07 a.m. and resumed at
5 10:07 a.m.)

6 MS. FLETCHER: We're going to switch
7 back to 1942 DC for just a moment.

8 I'd asked you, Ms. Yohannes, is there
9 a settlement agreement in this case, or are the
10 parties working on one?

11 MS. YOHANNES: No, there is not.

12 MS. FLETCHER: And I'm still in the
13 matter of 1942 DC. Ms. Yohannes, I just wanted
14 to tell you FYI, but I did get an email from Ben
15 Tesfaye.

16 MS. YOHANNES: Mm-hmm.

17 MS. FLETCHER: I did send him a WebEx
18 invitation, he asked me to send him one today.
19 So just FYI, I did send him one.

20 MS. YOHANNES: Thank you. I'm aware,
21 thank you.

22 MS. FLETCHER: You're welcome.

23 And I'll spell his name since I have
24 said it, his name is Ben, B-E-N, his last name is
25 Tesfaye, spelled T-E-S-F-A-Y-E, for the record.

1 MS. YOHANNES: Thank you.

2 MS. FLETCHER: Regarding the matter of
3 1942 DC, the protest is dismissed because the
4 Protestant is not present.

5 Ms. Yohannes, the Board will issue an
6 order dismissing the application. You'll receive
7 a copy of the order and you'll be informed if ANC
8 1B seeks reinstatement, and you'll have an
9 opportunity to respond.

10 MS. YOHANNES: Thank you very much,
11 have a good day.

12 MS. FLETCHER: You too, thank you.

13 The roll call hearing in the matter of
14 1942 DC is concluded.
