3 MS. FLETCHER: Good morning, I'd like  
4 to thank everyone for joining ABRA's public roll  
5 call hearings via the Webex platform. My name is  
6 Laverne Fletcher, I'll be conducting the roll  
7 call hearing as the board's agent. There are two  
8 cases on the calendar today.

9 The first case is District Sports Bar.  
10 This is Case Number 22-PRO-00102, 900 FL, LLC,  
11 900 Florida Avenue Northwest, License Number ABRA  
12 122413.

13 This is a retailer class CT new  
14 application. The protest issues are ABRA's  
15 impact on peace, order and quiet, residential  
16 parking and vehicular and pedestrian safety, and  
17 density.

18 My name is Laverne Fletcher conducting  
19 the roll call hearing as the board's agent. Is  
20 anyone present on behalf of the District Sports  
21 Bar?

22 MR. JACKSON: Yes, Jeff Jackson  
23 representing the applicant.

24 MS. FLETCHER: Thank you, Mr. Jackson.  
25 Would you spell your name for the record, please?

9 MS. FLETCHER: Okay, I'm going to move

3 settlement agreement.

4 MS. FLETCHER: Okay, we've got a  
5 couple more minutes.

9 MS. FLETCHER: With respect to the  
10 District Sports Bar, Mr. Jackson, ANC 1B is  
11 dismissed because they are not present.

14 order dismissing the protest. You will receive a  
15 copy of the order. You will have an opportunity  
16 to respond if the ANC seeks reinstatement.

19 Jackson, for coming. The roll call hearing in  
20 this matter is concluded. Thank you.

21 MR. JACKSON: Thank you.
