3 for a show cause hearing for a date to be  
4 determined. And it will probably be sometime in  
5 January, sir. So we will contact you. If you do  
6 hire an attorney between now and then, please  
7 ensure that the attorney makes an appearance.

8                   So please ensure that your attorney  
9 contact Mr. Lui to identify him or herself and  
10 also provide a letter of representation to the  
11 Agency. All right?

12                   So thank you very much, sir, and have  
13 a good day. So we'll call and inform you when  
14 this matter is scheduled for a show cause  
15 hearing. Thank you very much, sir.

16                   MR. IJITI: Okay. Thanks.

17                   CHAIRPERSON ANDERSON: All right.  
18 Thank you.
