CHAIRPERSON ANDERSON: So what the Board will do now since we have concluded our morning calendar, we are going to do our legal agenda.

The Offer in Compromise states as follows. The District of Columbia, jointly with the licensee/respondent makes this Offer in Compromise, OIC, to the Alcoholic Beverage Control Board as authorized by 23 DCMR Section 1604.5 for approval by the Board.

The parties understand that if the Board approves the OIC, the case will conclude and any scheduled show cause hearing will be vacated. Respondent will be obligated to abide by the terms of the OIC, any fines, suspension or other terms shown below.

If the Board doesn't approve the OIC, the matter will be continued to a scheduled show
cause hearing currently not set.
The Respondent has been advised that there is no obligation for acceptance of OIC. Respondent has been advised through service of the Notice of Status Hearing and Show Cause Hearing that at a show cause hearing Respondent may be represented by legal counsel, have subpoenas to require the production of witnesses and evidence, produce witnesses and evidence, cross-examine witnesses and apply to the Board for a qualified interpreter.

The terms of the OIC is as follows. For Charge 1, failure to keep and maintain books and records for three years in violation of DC Code Section 25-11(3)(j) and (k) and 23 DCMR Section 1204, statutory authority DC Code Section 823(a)(1), a written warning will be issued.

For Charge 2, purchasing alcoholic beverage from an off premises retailer in violation of DC Code Section 25-11(2)(c)-(2)(a) and 25-113(a)(5)(A), statutory authority DC Code Section 823(a)(1). The fine will be a $\$ 1,000$ fine to be paid within 90 days or the license will be suspended indefinitely until the fine has been paid.
