10                  CHAIRPERSON ANDERSON: Mr. Lui, are  
11 there any preliminary matters in this case?

12                  MR. LUI: Mr. Chairman, the parties  
13 have no offer in compromise to present at this  
14 time.

15                  CHAIRPERSON ANDERSON: All right,  
16 thank you very much. Do you have any preliminary  
17 matters you want to bring to the attention of the  
18 Board, Ms. Yohannes?

19                  MS. YOHANNES: No, I do not.

20                  CHAIRPERSON ANDERSON: All right,  
21 thank you. All right, then this matter will be  
22 scheduled for a show cause hearing at a date to  
23 be determined.

24                  I believe that the hearing will be  
25 scheduled sometime in January, but in the

1 interim, if the parties want to discuss this case  
2 and if the parties decide to settle the case,  
3 then through a written offer of settlement, that can be  
4 provided to the Board for the Board's approval,  
5 so I just want to let the parties know that that  
6 offer is, that's available.

7 The Board does, based on COVID, we do  
8 accept a written offer of settlement from both  
9 parties, okay, but if not, we will, the Board,  
10 the agency will provide you a date and time for  
11 the show cause hearing, and I want to thank  
12 everyone for their participation today. Thank  
13 you very much.

14 MS. YOHANNES: Thank you.
