5 Number 20-PRO-00016, Cloud Restaurant & Lounge
6 Sports Bar, License Number 93572.

7 Ms. Andrews, can you see if there's
8 anyone on the line regarding this establishment,
9 Cloud Restaurant & Lounge?

10 MS. ANDREWS: Sure. I think Mr. Fox
11 I still on the line.

12 CHAIRPERSON ANDERSON: Who is on?

13 MR. STOECKLEIN: Yes, I am. Thank
14 you.

15 MR. FOX: Mr. Chairman? Sorry if I'm

8 license was cancelled.

9 MR. FOX: I do understand that, sir.

10 CHAIRPERSON ANDERSON: You heard me,
11 Mr. Fox?

12 MR. FOX: Yes, sir. I understand.

13 CHAIRPERSON ANDERSON: All right. So
14 we're cancelling. So I'm cancelling the hearing
15 was -- I'm sorry, because the license was
16 cancelled. See Board Order Number 2020-813. And
17 so please advise your client that this process
18 needs to be started over again because the
19 license was cancelled.

20 And, Mr. Stoecklein, once -- if the
21 licensee reapplies for its license then you can,
22 if you still want to protest this matter, then
23 you can contact the Agency and you can either ask
24 them to carry over -- but you have to formally
25 let the Agency know that you're still protesting

1 this license.

2 MR. STOECKLEIN: I understand. Thank
3 you, Mr. Chairman.

4 CHAIRPERSON ANDERSON: All right. So
5 thank you very much. Everyone have a great day.

6 MR. FOX: Thank you, Mr. Chairman. I
7 believe that concludes my matters.

8 CHAIRPERSON ANDERSON: Thank you.
9 Have a great day, please. All right. Thanks.
