8 this -- normally if the protestant is not here,
9 we would dismiss the protestant.

10 But since there is an executed
11 Settlement Agreement that has not been provided
12 to the Board as yet and the representation that
13 was made by counsel is that she will submit it to
14 the Board, so what I will do is that the Board
15 then -- we will cancel this hearing pending the
16 submission of the Settlement Agreement for the
17 Board's review and approval. All right. So
18 thank you, Ms. Yohannes, for that. All right.

19 MS. YOHANNES: Thank you.

20 CHAIRPERSON ANDERSON: Thank you. All
