MS. FLETCHER: The next case on the calendar is Deset Ethiopian Restaurant, Case No. 22-PRO-00108, Deset Ethiopian Restaurant, LLC, 6128 Georgia Avenue, N.W., License No. ABRA 098818. This is a Retailer Class CT license renewal. The protest issues are adverse impact on peace, order, and quiet, residential parking, and vehicular and pedestrian safety, and real property values.

My name is LaVerne Fletcher conducting the Roll Call hearing as the board's agent.

Is anyone present on behalf of the establishment?

MR. ARAYA: Yes, ma'am.
MS. FLETCHER: If you could state your name and spell it for the record, please?

MS. NELSON: Hi, good morning. This is Candace Nelson. I am the ANC Commissioner for 4A-06 and I am representing ANC 4A today.

MS. FLETCHER: Thank you, Ms. Nelson. Would you spell your name for the record, please?

MS. NELSON: Yes. It's Candace, C-A-N-D-A-C-E. Last name Nelson, N-E-L-S-O-N.

MS. FLETCHER: Ms. Nelson, let me ask you something -- oh, so first of all, ANC 4A does have standing as a protestant, but did you receive the Webex invitation from me?
