3 AGENT FLETCHER: Are the parties
4 present in the matter of Randall Grocery --
5 Randall Grocery?

6 This is the Case #14-PRO-00088, B & S
7 Business Enterprises, Inc., trading as Randall
8 Grocery, 2924 Minnesota Avenue SE; License #ABRA-
9 019046. This is a Retailer Class B License
10 Renewal. The protest issues are adverse impact
11 on peace, order and quiet.

12 My name is La Verne Fletcher, and I'm
13 conducting the Roll Call Hearing as the Board's
14 Agent pursuant to D.C. Official Code 1601.2.

15 Introductions beginning with the
16 Applicant? Are you from Randall Grocery?

17 MR. SHIN: Yes, ma'am.

18 MS. FLETCHER: Okay. And your name?

19 MR. SHIN: My name's James -- J-A-M-E-
20 S. Last name is Shin -- S-H-I-N.

21 MS. FLETCHER: And Mr. Shin, would you
22 please write your contact information on that

1 sheet -- your daytime number and an email
2 address?

3 MR. SHIN: Sure.

4 MS. FLETCHER: Okay. Thank you.

5 Is anyone present from ANC 7B?

6 (No audible response.)

7 MS. FLETCHER: Mr. Shin, have you been
8 in communication with ANC 7B, or do you have a
9 settlement agreement, by any chance?

10 MR. SHIN: I talked to one of the
11 members, and they never bring no letters or
12 nothing. So I couldn't go farther than that.

13 MS. FLETCHER: ANC 7B is dismissed for
14 failure to appear.

15 Mr. Shin, you'll be kept informed
16 about what happens next.

17 MR. SHIN: Yes, ma'am.

18 MS. FLETCHER: ANC 7B will receive an
19 order dismissing the protest --

20 MR. SHIN: Yes, ma'am.

21 MS. FLETCHER: -- for failure to
22 appear today. They will have ten days to seek

1 reinstatement of the protest from the Board. But
2 you'll be kept abreast of what happens beyond
3 this point.

4 MR. SHIN: Yes, ma'am.

5 MS. FLETCHER: But as of today, there
6 is no protest pending.

7 MR. SHIN: Thank you.

8 MS. FLETCHER: But they have to be
9 given an opportunity to explain why they weren't
10 here today.

11 MR. SHIN: Yes, ma'am.

12 MS. FLETCHER: Okay. Thank you very
13 much.

14 MR. SHIN: Thank you, too.

15 MS. FLETCHER: The Roll Call Hearing
16 is concluded. Thank you.
