CHAIRPERSON ANDERSON: Good afternoon, everyone. We are back on the record, and for the folks who were not here with us this morning, we have six Board members online today. We have a quorum.

The Board members who are currently with us are Mr. James Short, Mr. Bobby Cato, Ms. Rafi Crockett, Ms. Jeni Hansen, and Mr. Ed Grandis. I believe that maybe before the day is over, Ms. Rema Wahabzadah might join us again, but she was here this morning, but I just wanted everyone to know who the Board members are who are with us today, and I just want to read something.

Before we get underway with the continuation of today's calendar, I need to make a few instructions very clear so that the conduct of these hearings is understood by everyone.

Today's hearings are being conducted through a Webex account provided by the D.C.

Office of Open Government. There are, I believe there are 16 cases on the afternoon calendar.

Once your case is called, I will take
