3 CHAIRPERSON ANDERSON: Good afternoon,  
4 everyone. We are back on the record, and for the  
5 folks who were not here with us this morning, we  
6 have six Board members online today. We have a  
7 quorum.

8 The Board members who are currently  
9 with us are Mr. James Short, Mr. Bobby Cato, Ms.  
10 Rafi Crockett, Ms. Jeni Hansen, and Mr. Ed  
11 Grandis. I believe that maybe before the day is  
12 over, Ms. Rema Wahabzadah might join us again,  
13 but she was here this morning, but I just wanted  
14 everyone to know who the Board members are who  
15 are with us today, and I just want to read  
16 something.

17 Before we get underway with the  
18 continuation of today's calendar, I need to make  
19 a few instructions very clear so that the conduct  
20 of these hearings is understood by everyone.

21 Today's hearings are being conducted  
22 through a Webex account provided by the D.C.  
23 Office of Open Government. There are, I believe  
24 there are 16 cases on the afternoon calendar.

25 Once your case is called, I will take

1 a moment for our IT specialist to elevate the  
2 rights for each party to enable their camera and  
3 microphone. Then, and only then, will you have  
4 the ability to enable your equipment. If your  
5 case is not being heard, you will remain mute and  
6 your camera will be disabled.

7 At the conclusion of each case, the  
8 parties will have the option to leave. If the  
9 party chooses to stay, all cameras and  
10 microphones for the concluded case will be  
11 disabled.

22 MS. ANDREWS: That's all, Mr. Chair.  
23 The licensee for this case does not appear to be  
24 online.

25 CHAIRPERSON ANDERSON: All right,

1 thank you. All right, would you introduce  
2 yourself for the record, please?

3 MR. ASIM: Good afternoon, members of  
4 the Board, Shahzeb Asim, and I represent the  
5 District of Columbia, and the spelling is S-H-A-  
6 H-Z-E-B, last name A-S-I-M.

7 CHAIRPERSON ANDERSON: Thank you. All  
8 right, my records show that the licensee -- let  
9 me just get some clarification. Is there anyone  
10 online who is representing the Churreria Madrid  
11 Restaurant? If you are there, please identify  
12 yourselves through the chat, please.

13 All right, it's my understanding that  
14 the licensee was served on 11/20/2020. This  
15 matter will be scheduled for a show cause hearing  
16 in the new year, sometime in January. The agency  
17 will inform the parties of the date and time for  
18 the hearing. All right, thank you.
