AGENT FLETCHER: Okay, is ANC 1A present in the matter of Joint Chiefs?

Would the Applicant in the matter of Joint Chiefs step forward, please? Thank you.

Thank you. You can sit right there and if you would state your name and spell it for the record.

MR. ANDRADE: John Andrade, last name is spelled A-N-D-R-A-D-E.

AGENT FLETCHER: Thank you, Mr. Andrade, and would you please fill out that sheet on the table?

MR. ANDRADE: Yes.

AGENT FLETCHER: ANC 1A is not present and dismissed as a Protestant in this matter.

This is Case No. 13-PRO-00163 Notta Bike or Bar.

MR. ANDRADE: That is me, as well.

1 AGENT FLETCHER: Thank you, LLC,
2 trading as Joint Chiefs, 3400 11th Street,
3 Northwest, License No. ABRA-083926. This is
4 a Retailer CT License Renewal.

5 The protest issues are adverse
6 impact on peace, order and quiet, residential
7 parking and vehicular and pedestrian safety.

8 Mr. Andrade, you'll be kept
9 informed of the progress in this case. ANC 1A
10 will receive an order dismissing the protest.

11 You will be -- receive a copy of
12 the order, as well, and if ANC 1A does seek
13 reinstatement of its protest, you'll have an
14 opportunity to oppose it.

15 MR. ANDRADE: Okay.

16 AGENT FLETCHER: Any questions
17 about that at all?

18 MR. ANDRADE: Just to clarify,
19 this is for both licenses? One is for Joint
20 Chiefs and one is for Meridian Pint?

21 AGENT FLETCHER: No, the Roll Call
22 Hearing today is only for Joint Chiefs.

1 MR. ANDRADE: Okay.

2 AGENT FLETCHER: Yes, what is the
3 other place you mentioned?

4 MR. ANDRADE: Meridian Pint.

5 AGENT FLETCHER: Yes, that's not
6 on the calendar for today. Maybe it's for an
7 upcoming Roll Call Hearing, but you can let me
8 know what your notice says.

9 MR. ANDRADE: Okay, the notice is
10 only for Joint Chiefs, however, their original
11 -- well, okay, that's fine.

12 AGENT FLETCHER: Yes, there may be
13 a roll call -- a separate Roll Call Hearing
14 for the other establishment on a different
15 day.

16 MR. ANDRADE: Okay, so, it's
17 dismissed?

18 AGENT FLETCHER: Yes.

19 MR. ANDRADE: And if they want to
20 reinstate?

21 AGENT FLETCHER: They can --

22 MR. ANDRADE: And I'll have the

1 opportunity to request for dismissal of that?

2 AGENT FLETCHER: Well, it's
3 already been dismissed.

4 MR. ANDRADE: Okay.

5 AGENT FLETCHER: The protest has
6 already been dismissed. If they seek
7 reinstatement of the protest -- well, let me -
8 - the Board is going to issue them an order
9 dismissing the protest because they did not
10 come today.

11 MR. ANDRADE: Okay.

12 AGENT FLETCHER: If they decide to
13 seek reinstatement of their protest, you'll
14 receive a copy of that, and they have an
15 opportunity to respond to it.

16 MR. ANDRADE: Okay, will that be -
17 -

18 AGENT FLETCHER: You might be
19 opposed to that --

20 MR. ANDRADE: Will that mean we
21 will have to come here again?

22 AGENT FLETCHER: No, this is --

1 that is all done by paper.

2 MR. ANDRADE: Okay.

3 AGENT FLETCHER: Yes.

4 MR. ANDRADE: All right, thank
5 you.

6 AGENT FLETCHER: So, you don't
7 need to do anything, just to wait to see what
8 happens, and you'll be kept abreast of what
9 happens beyond this point.

10 MR. ANDRADE: Okay, thank you.

11 AGENT FLETCHER: Okay, thank you.

12 Thank you for coming.

13 The Roll Call Hearing is
14 concluded.
