3 MS. FLETCHER: The last case on the
4 calendar for today is 801 Restaurant and Bar.
5 This is Case Number 22-PRO-00126, 801 Restaurant,
6 LLC, 801 Florida Avenue, Northwest, License
7 Number ABRA-103120.

8 This is a Retailer Class CT License
9 Renewal. The protest issues are adverse impact
10 on peace, order, and quiet.

11 My name is LaVerne Fletcher,
12 conducting the roll call hearing as the Board's
13 agent. Is anyone present on behalf of 801
14 Restaurant and Bar?

15 MR. HEIDENBERGER: Yes. This is Eric
16 Heidenberger. E-R-I-C, last name H-E-I-D-E-N-B-
17 E-R-G-E-R.

18 MS. FLETCHER: Thank you, Mr.
19 Heidenberger. Anyone present on behalf of ANC
20 1B?

21 MS. HARRIS: Yes. This is
22 Commissioner Sabel Harris. S-A-B- as in boy, E-L
23 H-A-R-R-I-S.

24 MS. FLETCHER: Thank you, Ms. Harris.
25 ANC 1B does have standing as a Protestant. I

1 will give you the date for the status and protest
2 hearing first and then we'll set a date for
3 mediation.

4 The status hearing is scheduled for
5 February 1, 2023, at 10:30 a.m. The protest
6 hearing is set for March 8, 2023, at 1:30.

7 The last available day for mediation
8 in December, actually we have two days available
9 for mediation in December. Both at 2:00 on
10 December 22 at 2:00 is available, and December 28
11 at 2:00 is available.

12 Otherwise, we'll move to January.

13 MS. HARRIS: This is Commissioner
14 Sable Harris. We would prefer December 22 at
15 2:00, if that's possible.

16 MS. FLETCHER: Is that good for your
17 Mr. Heidenberger?

18 MR. HEIDENBERGER: The 22nd at 2:00?
19 Yeah. That should be fine.

20 MS. FLETCHER: Mediation is set for
21 Thursday, December 22, at 2:00.

22 MS. HARRIS: And Ms. Fletcher, this is
23 again, Commissioner Sabel Harris. Is it possible
24 to add my colleague, Commissioner Dan Orlaskey?

25 MS. FLETCHER: Dan Orlaskey?

1 MS. HARRIS: Yes. Thank you.

2 (Laughing.)

3 MS. FLETCHER: Okay. I have just
4 added Mr. Orlaskey. Thank you very much. Let's
5 see, okay.

6 Well, those are all the cases on the
7 calendar for today. Is there anyone I haven't
8 spoken with that I should be speaking with?

9 (No response.)

10 MS. FLETCHER: Okay. Well, I'd like
11 to thank you for coming. The roll call hearing
12 in this matter is concluded.

13 And, those are all of the hearings for
14 today.

15 MS. HARRIS: Thank you.

16 MS. FLETCHER: I'm going to sign off.
17 Thank you everybody.
