3 MS. FLETCHER: The next case on the
4 calendar is Cloud Restaurant and Lounge. This is
5 Case Number 22-PRO-00124, Kat, LLC, 1919 9th
6 Street, Northwest, License Number ABRA-093572.

7 This is a Retailer Class CT License
8 Renewal. The protest issues are adverse impact
9 on peace, order and quiet.

10 My name is LaVerne Fletcher conducting
11 the roll call hearing as the Board's agent. Is
12 anyone present on behalf of Cloud?

13 MR. BIANCO: Good morning again, Ms.
14 Fletcher. Richard Bianco for Cloud Lounge. R-I-
15 C-H-A-R-D B-I-A-N-C-O.

16 MS. FLETCHER: Thank you, Mr. Bianco.
17 Is anyone present on behalf of ANC 1B?

18 MS. HARRIS: Yes. This is
19 Commissioner Sabel Harris. S-A-B- as in boy, E-L
20 H-A-R-R-I-S.

21 MS. FLETCHER: Thank you, Ms. Harris.
22 ANC 1B does have standing as a protestant. I
23 will give you the dates for the status and
24 protest hearing and then set a date for
25 mediation.

1 The status hearing is set for February
2 1, 2023, at 10:30. The protest hearing is for
3 March 8, 2023, at 1:30.

4 I will give you the next available
5 date for mediation. Ms. Harris, I'm going to ask
6 you this question based on what you stated in a
7 previous case.

8 You prefer to have mediation scheduled
9 in the month of December?

10 MS. HARRIS: Yes. That is correct.

11 MS. FLETCHER: I will see if there's
12 another day in December. And then check with Mr.
13 Bianco to see if that works for him.

14 MR. BIANCO: The 27 and 29 are
15 available to mediate if the ANC is.

16 MS. FLETCHER: Okay. Well, we can do
17 -- we can do the 27th at 1:30 in the afternoon.

18 MR. BIANCO: I'm available.

19 MS. HARRIS: That works for us.

20 MR. BIANCO: And that was 1:30 p.m.,
21 correct, Ms. Fletcher?

22 MS. FLETCHER: Yes. 1:30 p.m., yes.

23 MR. BIANCO: Okay.

24 MS. FLETCHER: Okay. So, Cloud is set
25 for mediation on Tuesday, December 27, at 1:30 in

1 the afternoon.

2 MS. HARRIS: And Ms. Fletcher, this is
3 Commissioner Sabel Harris. Are you also able to
4 add my colleague Commissioner Dan Orlaskey to
5 that as well?

6 MS. FLETCHER: Yes.

7 MS. HARRIS: Thank you.

8 MS. FLETCHER: You're welcome. Okay.
9 I've just added Mr. Orlaskey. Okay. Then we're
10 all set. I'll see you on the 27th at 1:30.

11 Thanks for coming.

12 MR. BIANCO: Thank you.

13 MS. HARRIS: Thank you, Ms. Fletcher.

14 MS. FLETCHER: Awesome. Bye Mr.

15 Bianco.
