3 CHAIRPERSON ANDERSON: We're back on
4 the record.

5 Let's now do our, our agenda items for
6 the day, since we have concluded our calendar for
7 the day. So, this is our regular legal agenda.

9 agenda is the Review of an offer in Compromise in
10 Lieu of a Hearing, dated November 24, 2023, for
11 Case No. 23-251-00015, Shaw Howard Deli, License
12 No. 096169.

13 The offer in compromise is as follows:

14 Charge 1. Allows the establishment to
15 be used for an unlawful purpose. Statutory
16 Authority, D.C. Code Section 25-823(a)(2). The
17 term, \$4,000 fine to be paid within 30 days or
18 the license shall be suspended indefinitely until
19 the fine has been paid.

20 Charge 2. Failed to follow security
21 agreement. Statutory Authority, D.C. Code
22 Section 25-823(a)(6). The term, \$500 to be paid
23 within 30 days or the license shall be suspended
24 indefinitely until the fine is paid.

25 Charge 3. Failed to ensure cameras

1 were operational. Statutory Authority, D.C. Code
2 Section 25-112(f)(1). Term, \$4,000 to be paid
3 within 30 days or the license shall be suspended
4 indefinitely.

5 I, therefore, make a motion that the
6 offer in compromise be accepted.

12 items. And so, if there is no further business,
13 I will close the record for this day.
