Do you have any questions, sir?

MR. GIRMA: No, I don't.

CHAIRPERSON ANDERSON: All right. And failure by either side to disclose documents and witnesses seven days before the hearing, unless proper cause is shown, the Board is empowered to prevent that side from moving forward, relying on
