19	MS. ANDREWS: I sure will.
20	CHAIRPERSON ANDERSON: Thank you. All
21	right. The all right. Ms. Traverso, do you
22	have a camera? Or if you don't
23	MS. TRAVERSO: I do not, no.
24	CHAIRPERSON ANDERSON: Okay. That's
25	fine. All right. Let's start with have the

parties introduce themselves for the record, and 1 2 let's start with the Government, please. 3 MR. ADAMS: Good afternoon, Mr. Chairman. Walter Adams representing the District 4 of Columbia. 5 CHAIRPERSON ANDERSON: Good afternoon 6 7 And Ms. Traverso, can you please Mr. Adams. 8 state your name for the record and please spell 9 your name and please identify your relationship 10 with the establishment, please? 11 MS. TRAVERSO: My name is Rachel 12 It's R-A-C-H-E-L, and Traverso is T-R-Traverso. 13 A-V as in Victor, E-R-S-O. And I'm the owner of the licensed establishment. 14 15 CHAIRPERSON ANDERSON: Okay. Thank 16 you. All right. Mr. Adams, are there any 17 preliminary matters in this case? 18 MR. ADAMS: There is a preliminary 19 matter, Mr. Chairman. The parties have discussed 20 a settlement of this case and we'll propose an 21 offer in compromise. 22 CHAIRPERSON ANDERSON: And what is the 23 offer in compromise, please? 24 MR. ADAMS: Mr. Chairman, the offer in 25 compromise for this case which has a single

charge which alleges that the establishment 1 2 failed to keep and maintain its books and records 3 for a period of three years. The parties have agreed to resolve this matter with a warning. 4 5 CHAIRPERSON ANDERSON: All right. Thank you, Mr. Adams. Ms. Traverso, it's my 6 7 understanding that there's an offer in compromise 8 and the offer in compromise is that for the 9 charge, failure to maintain on premises -- books 10 and records on premises for three years that 11 there will be a warning. Is this your 12 understanding of the offer in compromise? 13 MS. TRAVERSO: Yes. 14 CHAIRPERSON ANDERSON: Are you aware 15 that by accepting an offer in compromise that 16 you're giving up your right to a hearing? 17 MS. TRAVERSO: Yes. 18 CHAIRPERSON ANDERSON: Are you also 19 aware that by accepting an offer in compromise 20 that you've given up your right to appeal this 21 matter? 22 MS. TRAVERSO: Yes. 23 CHAIRPERSON ANDERSON: With that said, 24 I make a motion that the offer in compromise in

this matter of a written warning be accepted.
