CHAIRPERSON ANDERSON: All right. The next case on our calendar is Case No. 20-CMP-00032, Roofer's Union-Jug and Table, License No. 93592. Ms. Andrews, can you please elevate the rights of the licensee in this case, please?

MS. ANDREWS: Mr. Large, you are a panelist. That's all, Mr. Chair.

CHAIRPERSON ANDERSON: Thank you. All right. Mr. Adams, can you please identify yourself for the record, please?

MR. ADAMS: Good morning, Mr. Chairman. I'm Walter Adams representing the District of Columbia.

CHAIRPERSON ANDERSON: Good morning, Mr. Adams. Mr. Large, can you please identify yourself for the record and your relationship to the establishment? Can you also spell your name for the record, please?

MR. LARGE: Yes, Curtis Large, C-U-R-T-I-S, last name, L-A-R-G-E. And I'm the -- I'm a partner. I'm a managing member of Roofer's Union.

CHAIRPERSON ANDERSON: All right.

1 Thank you, Mr. Large. All right. Mr. Adams, are
2 there any preliminary matters in this case?

3 MR. ADAMS: Yes, there is, Mr.
4 Chairman. The parties have discussed this matter
5 and have reached a settlement and would like to
6 propose an Offer in Compromise to the Board.

7 CHAIRPERSON ANDERSON: And what is
8 that, please?

9 MR. ADAMS: In this case where there's
10 a single charge for the establishment operating
11 outside of its approved hours, the parties have
12 agreed that the case could be resolved with a
13 warning, a written warning by the Board.

14 CHAIRPERSON ANDERSON: All right.
15 Thank you, Mr. Adams. Mr. Large, it's my
16 understanding there's an Offer in Compromise, and
17 the Offer in Compromise for the single charge is
18 that a warning will be issued. Is this your
19 understanding, sir, of the Offer in Compromise?

20 MR. LARGE: Yes, that's my
21 understanding.

22 CHAIRPERSON ANDERSON: Are you also
23 aware that by accepting an Offer in Compromise
24 that you're giving up your right to a hearing?

25 MR. LARGE: Yes, I understand that.

1 CHAIRPERSON ANDERSON: Are you also
2 aware that by accepting an Offer in Compromise
3 that you're giving up your right to appeal this
4 matter?

5 MR. LARGE: Yes.

6 CHAIRPERSON ANDERSON: All right.
7 Thank you. Are there any questions by any Board
8 members?

9 (No response.)

10 CHAIRPERSON ANDERSON: Hearing that,
11 I make a motion that the Offer in Compromise of a
12 warning be accepted. Is there a second?

13 MEMBER CROCKETT: Ms. Crockett
14 seconds.

15 CHAIRPERSON ANDERSON: Ms. Crockett
16 has second the motion. We'll now have a roll
17 call vote on the motion that has been properly
18 second by Ms. Crockett. Mr. Short?

19 MEMBER SHORT: Mr. Short, I agree.

20 CHAIRPERSON ANDERSON: Mr. Cato?

21 MEMBER CATO: Bobby Cato, I agree.

22 CHAIRPERSON ANDERSON: Ms. Crockett?

23 MEMBER CROCKETT: Rafi Crockett, I
24 agree.

25 CHAIRPERSON ANDERSON: Ms. Hansen?

1 MEMBER HANSEN: Jeni Hansen, I agree.

2 CHAIRPERSON ANDERSON: Mr. Grandis?

3 MEMBER GRANDIS: Ed Grandis, I agree.

4 CHAIRPERSON ANDERSON: And Mr.

5 Anderson, I agree. The matter passes 6-0-0. I
6 would like to thank both parties for coming to an
7 agreement in this matter. If there are no
8 further questions, have a great day. Thank you
9 very much.

10 MR. LARGE: Thank you.

11 MR. ADAMS: Thank you, Mr. Chairman.

12 CHAIRPERSON ANDERSON: Bye-bye.
